Item 2-1: Scope of work has been revised to include only the re-roof part of the original project scope. The heating units and the door replacement part of the original project will be bid as a separate project at a later date.

8 – CLARIFICATIONS:

Item 8 – 1: Scope of the project revised from Re-Roof to Retrofit.

- A. Standing seam roof to remain.
- B. Infill in-between seams with polyisocyanurate insulation.
- C. Furnish & Install 1" protection board.
- D. 60 mil TPO Rhino System installed with wind warranty design.

Item 8-2: Remove snow guards (salvage for reinstallation) and add $4" \times 4"$ pressure treated lumber under TPO Membrane, staggered in two rows to overlap in equal dimensions. Reinstall snow guards in various areas.

Item 8-3: Remove and dispose of existing rain gutters and downspouts. Replace with new steel rain gutters and downspouts as follows:

- A. Rain gutters and downspouts will be residential style where feasible.
- B. Larger rain gutters will be required in specific areas.
- C. The downspouts should be similar to the existing downspouts on the east side of the school. See attached photo (exhibit 01) for locations of each type.

Item 8 – 4: Modify roof curbs for 6 each for existing HVAC mechanical units. Modify existing exhaust fans units and extend a minimum of 6".

Item 8-5: Furnish and install a 5' x 5' (minimum size) aluminum roof hatch and curb to facilitate removal and replacement of HVAC equipment. Approved manufacturers are Babcock Davis and Bilco. Other manufacturers may be bid pending approval of Owner or Construction Manager before bid date.

Note: the CM/GC will build the curb and supply the roof hatch. The roofing contractor will be responsible for installing the roof hatch.



8 – CLARIFICATIONS: (Continued)

Item 8 - 6: Remove and salvage all heat trace cables and replace the heat trace cables in the new rain gutters only.

Item 8-7: All vertical standing seam façade to remain. The new retrofit scope for roofing is to be included also for all vertical standing seam areas where the new TPO roof membrane is being installed.

Item 8 - 8: Bid form will include a line item for optional pricing to furnish and install walking mats. (per linear foot).
