1. Room 105 – Stake President. Install new 5/8" gypsum board at wall where opening is infilled with new framing. Fully insulate wall prior to installation of gypsum board. Tape, texture and paint new wall. Patch, repair and paint existing block walls. Remove and re-install carpet base on new wall. Remove trim and sisal wainscot. Install new hardwood chair railing and sisal wainscot all walls.

- 2. Room 106 shall read High Council. Existing finishes to remain. Install new lighting as indicated.
